The Japan International Cooperation Agency (JICA) in Sri Lanka has invited nominations for the above training programme scheduled to be held in Japan from 05th July 2026 to 18th December 2026. The details of the programme and application guidelines are enclosed for your reference. This programme is designed for officials who are responsible for hydrographic survey or nautical chart to be certified to Internationally Accredited Category B for Hydrographic survey.

Accordingly, you are kindly requested to circulate this information among the relevant officers of your Institutions/divisions and send the nominations with the following documents on or before 2.00 p.m on 27th March 2026. Each nominee should meet the stipulated eligibility criteria. Nominations should be submitted in accordance with the General Information (GI) guidelines and in compliance with TA Circular No. 2013/2014 (ii) dated 24 October 2013 issued by the Ministry of Finance and planning.

- 2 sets of duly filled prescribed Application form (new official application form can be downloaded from www.erd.gov.lk. Please note that hand written applications will not be accepted. (Kindly advice the nominees to use the name exactly as it appears in their passports in all documents related to the programme)
- 2 copies of the nominee's English Score Sheet. (e.g. TOEFL, TOEIC, IELTS)
- 2 copies of the passport
- 2 copies of the Country report (Annex 1)
- 2 copies of the Questionnaire (Annex 2)

- Two sets of duly filled ERD Form (available at www.erd.gov.lk)
- Duly filled Sop format
- Details of the Previously participated foreign trainings under JICA

Kindly note that the ERD has stated that, officials already trained under the JICA Programme will not be qualified for another JICA training programme within two (02) years of such training.
