1. The **Chairman, Department Procurement Committee (DPC)** on behalf of “**Ceylon Fishery Harbours Corporation**” invites sealed Bids from eligible and qualified Bidders for above work. This work include demolition works, removing works, concrete works, blocks and brick works, filling works, tiling works and re-fixing aluminium doors and windows and painting works etc. Approximate cost of **Engineers estimate is 10.75 Million** without contingencies and VAT.
2. Bidding will be conducted through **National Competitive Bidding**.
3. The Bidder shall comply with the following eligibility criteria:
 - Bidder shall not have been blacklisted
 - Registration with CIDA in the field of **Building Construction in grade C7, C6 and C5** at the time of the submission of the Bid.
4. The Bidder shall comply with the following qualification criteria:
 - Average annual volume of construction work performed in last five years (2019,2020,2023,2024,2025) shall be at least **LKR 10.75 million**
 - Experience as prime contractor in the construction of at least one contract of a similar nature and complexity equivalent to the Works over the last 10 years (to comply with this requirement, works cited should be at least 70 % complete). **LKR 7.5 million**
 - The minimum amount of liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, until Project Completion Date, shall be not less than **LKR 10.75 million**
 - The Bidder should Poses a valid certificate issued by the Registrar of Public Contracts in accordance with the section 8 of Public Contracts Act number 03 of 1987 for every bid which exceeds tenderable amount of Rupees 5 million. This will be a qualification to award the Contract.
5. The Construction period for this bid is 90 calendar Days and Location of the Project at Chilaw Fishery Harbours at Puttalam District.
6. 8. Bids shall be valid up to **27.10.2026 (77 Days)**
9. All Bids shall be accompanied by a bid security (**Bank guarantee or refundable cash deposit**) of Rupees **One Hundred Sixty Thousand (Rs. 160,000.00)** only valid for **105 days (24.11.2026)** from the date of opening of bids. **The copy of the deposit slip shall be attached with the Bid.**

Sealed Bids may be delivered with the Duplicate to “**Chairman, Department Procurement Committee, Procurement Division, Ceylon Fishery Harbours Corporation, No. 15, Rock House Lane, Colombo 15**” on or before **12.08.2026 at 11.00 a.m.** Late bids will be rejected. Bids will be opened soon after the closing in the presence of the Bidders’ representatives who chooses to attend. (Bidders or their authorized representatives are requested to be present at the opening of Bids).
